At Hodnet school we aim to: -

- Ensure that clothing is appropriate for all activities in school.
- Avoid unpleasant comparisons or competition over clothes.
- Ensure that clothing does not detract from schoolwork.

We ask that all pupils wear school uniform in our school colour of royal blue. Wearing uniform is important as it fosters a feeling of pride in belonging to our school family. Our school standard dress is simple, cheerful, it looks smart and it wears well. It is also good value for money, in line with the government requirements 2022.

### **Purchasing uniform**

All our products with the school logo on are available for families to purchase via Stitch Design on their website [stitchdesign.co.uk](http://stitchdesign.co.uk). Purchases can be delivered to school or direct to home addresses. Other non logo items can be purchased at most supermarkets or high street stores. Royal blue cardigans and/or jumpers without a school logo are acceptable uniform items.

### **Uniform**

Pupils are asked to wear the following items ~

- ✓ Royal blue jumper or cardigan with school logo (*available from stitch Design*)
- ✓ Grey skirt or pinafore dress or trousers or shorts
- ✓ White or pale blue polo T-shirt or shirt or blouse
- ✓ Pale blue summer dress (blue checked material)
- ✓ Black flat school shoes (not trainers or shoes with heels) short ankle flat boots maybe worn in the winter months.

Children **MUST NOT** wear varied sportswear, including football shirts and socks, jeans, tracksuit bottoms, beachwear, cropped or sleeveless T-shirts, leggings, trainers, shoes with heels or tall boots.

### **PE kit**

For health and safety reasons it is important that all pupils are dressed appropriately for any physical activity.

- **All children need to wear a plain white T shirt and navy or black shorts.** No leotards or sports kits including no football shirts or socks. Jogging bottoms and a jumper may be worn in the winter months.
- **Indoor PE sessions** ~ Pupils take part in bare feet. This is important when using the apparatus or during dance sessions as it ensures a firm, controlled grip.
- **Outdoor PE sessions** ~ Pupils need a pair of trainers, not pumps as these are not supportive enough for children's ankles.
- PE kit should be kept in a named drawstring bag (*can be available from Stitch Design*). Parents are asked not to buy their child any other type of large bag as we have limited space in our cloakrooms.
- PE kit is best kept at school and returned home for washing at weekends or holidays. Parents are asked to regularly check that their child's kit still fits, especially their trainers.
- **Swimming kits** are required in KS2 at specific times of the year when the children attend the local swimming centre to complete their swimming curriculum entitlement. They need a swimming costume or swimming shorts, no bikini's or tankini's. All children require a towel. Goggles and swimming caps are optional. Verruca socks must be worn when needed if a child has a verruca. Earrings must be removed.

### **Jewellery, hair and make-up**

For health and safety reasons, if pupils wish to wear earrings, these **MUST be the stud design only**, no loops or dangling earrings or large gemstones. Pupils must remove their own earrings for PE sessions, these cannot be taped over or removed by staff. Pupils may wear a watch, but rings, necklaces and bracelets must be left at home and are not permitted in school. Hair accessories such as slides, ribbons, bobbles etc should be simple and preferably in the school colour of royal blue. Large bows or large raised

headbands are not permitted. Long hair (girls and boys) must be tied back, preferably for the whole day, definitely during PE sessions. Make up is not permitted in school.

### **Sun protection**

Children are encouraged to bring a sun hat to wear for protection whilst out in the playground during the summer and early autumn. They can also bring sunglasses if they wish, but these are the children's responsibility to keep safe. Parents are encouraged to apply sun cream on their child before they arrive at school. Staff are not able to re-apply this during the school day.

### **Cold weather**

Our playground is quite an exposed area and can be particularly cold during the winter months. We often reduce the length of the playtime if the weather is particularly cold or foggy. Children are encouraged to have a warm coat, hat, scarf, and gloves to wear.

### **Named items**

The only disadvantage to wearing school uniform is the obvious one... everyone's jumper looks the same! Our lost property box is located in the main school office and by the end of each term it is usually overflowing with odd gloves, socks, hats and of course jumpers!

To save time, trouble, upset and money, parents are asked to clearly name all school uniform items and check regularly that their child's name is still clearly visible.

### **Additional items**

We also sell the following items, all available from Stitch Design ~

- ✓ School waterproof fleece coats with our school logo
- ✓ Reading book bags with logo, recommended for all Reception pupils. Large bags are not necessary for any pupils. If children prefer a rucksack rather than a book bag as they get older, then these must be kept to a minimum size, as we do not have space to accommodate large bags in our cloakroom areas.

### **Inclusion**

The policy will be applied to all pupils. We welcome our general responsibilities under the Disability Equality Duty by promoting equal opportunities, eliminating discrimination and improving access to learning for disabled people. In order to comply with the requirements of the DDA we will make reasonable adjustments to ensure all stakeholders understand and can follow this policy. We will actively seek to remove any barriers to learning and participation that may hinder or exclude individuals or groups of pupils.

### **Monitoring and review**

This policy is monitored by the Headteacher, who reports to governors about the effectiveness of the policy on request. It will be reviewed appropriate to new legislation or to the needs of the school.
